Personal data that we process

DECR processes your personal data because you joined one of our courses or because you provided them to DECR.

Below you will find a list of personal data that DECR will process:

- First and last name
- Address information
- Phone number
- Email address
- IP address
- Bank account number
- Location data
- Internet browser and device type
- Other personal data, which you provided in correspondence

Special and/or sensitive personal data that we process

DECR does not intend to collect information about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However DECR cannot check whether a visitor is over the age of 16. If you are convinced that DECR collected personal information about a minor without permission, please send an email to info@decrotterdam.com so we can remove the data.

The purpose and the lawful basis for processing personal data

DECR processes your personal data for the following purposes:

- To call or email you
- To inform you about changes of services and products

Automated decision making

DECR does not take decisions through automated processing on matters, which may have (considerable) impacts on people. We are talking about decisions taken by computer programs or systems, without the interference of an employee of DECR.

How long we store personal data

DECR stores your personal data no longer than is strictly necessary to achieve the goals for which your information is collected.

Sharing of personal information with third parties

DECR will only share personal records with third parties if it is necessary for the execution of an agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, we use

DECR uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in your computer's browser, tablet or smartphone, when you first visit our website.

See, modify or delete data

You always have the right to ask for your personal information, to correct and to remove it. In addition, you also have the right to pull or to object to the processing of your personal data by DECR. Furthermore, if you would want a copy of your personal information, you can submit a request and have it sent to yourself or /and organisation of your choosing. This request can be emailed to info@decrotterdam.com.

To ensure that the request is done by you, DECR will always ask for a copy of your identification.

DECR will respond to your request within four weeks.

DECR would also like to point out that you always have the possibility to file a complaint with the Dutch Data Protection Authority (Dutch DTA).

How we protect personal information

DECR will always take the appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification of your personal data.
